

**FILLING UP OF THE POST OF GENERAL MANAGER, RASHTRIYA MAHILA KOSH, AN ORGANISATION UNDER M/o WOMEN & CHILD DEVELOPMENT, GOVT. OF INDIA.**

The Ministry of Women and Child Development, Government of India, proposes to fill up the post of General Manager, Rashtriya Mahila Kosh, a society registered under Societies Registration Act, 1860 under this Ministry. The General Manager is the second senior most officer of RMK. General Manager, Rashriya Mahila Kosh is a DS/Director level post and is filled through Selection on Deputation/absorption including short term contract basis. Officer at the level of Director holding analogous post or an officer of the rank of DS with 5 years experience in the GP of Rs. 7600/- or an officer in the rank of US having 10 years experience in GP 6600/- in the Govt. of India belonging to the All India/Central Services and having experience in any one or more of the areas viz., working in economic ministries, rural development, women & child development or social welfare are eligible against the Director Level post. Further, an officer at the level of Deputy Secretary or an officer of the rank of Under Secretary with 5 years experience in the GP of Rs.6600/- in the Govt. of India belonging to the All India/Central Services; and having experience in any one or more of the areas viz., working in economic ministries, rural development, women & child development or social welfare are eligible for the DS Level post. Besides, Scale IV or Scale V officers working in any of the Public Sector Banks/Development Banks like NABARD, SIDBI etc., with experience of Funds Management /Rural Credit /lending through SHGs/Micro Credit Programmes etc are also eligible. **Subject: Filling up the post of General Manager, a Selection Post in Rashtriya Mahila Kosh on Deputation/Absorption (including short -term contract).**

Sir/Madam,

Rashtriya Mahila Kosh(RMK) is a registered society under Society Registration Act , 1860 under the Ministry of Women and Child Development . The main objective of RMK is to provide micro-credit to poor women for livelihoods support and income generating activities at concessional terms. There is one vacant post of General Manager which is proposed to be filled up through selection on/transfer on deputation/absorption including short-term contract basis. Officers working in Government of India belonging to All India/Central Services with experience of working in Economic Ministries or any or more of the areas viz. Rural Development /Banks like NABARD, SIDBI etc. with experience of fund management /rural credit /lending through SHGs/Micro Credit Programmes etc. are also eligible.

2. Detailed particulars, eligibility requirements etc. in respect of the post are enclosed (Annexure-I). Persons selected on deputation/absorption basis will be entitled to the normal deputation/absorption terms as admissible under the Central Government Rules in force from time to time. The periods of deputation (including short term contract), including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department shall ordinarily not exceed five years. The deputationist may also be considered for absorption.

3. The maximum age limit for the candidates for appointment is 56 years as on the closing date of receipt of application prescribed.

4. It is requested that particulars of eligible and interested officers duly verified and countersigned by the employer may be forwarded through proper channel in the attached Performa (Annexure II) along with their up to date Confidential Report /dossiers or Photocopy of ACRs duly attested by officer not below the rank of Under Secretary on each page for the last five years and Integrity Certificate/Vigilance Clearance and Penalty Statement imposed

during the last ten years so as to reach this Ministry within eight weeks from the date of publication of this circular in the Employment News/ Rozgar Samachar.

5. The candidates who apply for the post will not be allowed to withdraw their candidature subsequently.

6. The applications received without upto date confidential reports/ Vigilance Clearance/ Integrity Certificate or otherwise found incomplete will not be entertained.

**PROFILE OF RASHTRIYA MAHILA KOSH (RMK):** Rashtriya Mahila Kosh(RMK) is a registered society under Societies Registration Act , 1860 under the Ministry of Women & Child Development . The objective of RMK is to provide micro- credit to poor women for various livelihood support and income generating activities.

**2. QUALIFICATION AND EXPERIENCE:**

Age limit for recruitment on short term contract below 45 years.

Educational and other qualifications required for recruits on short term contract:

A) Post Graduate in Social Sciences from a recognized University with a minimum of 55% marks.

B) Minimum 7 years experience in the social or economic sector, preferably in the management of micro credit programmes, SHGs. Preference will be given to those candidates with a proven track record and a high level motivation towards work in the social sector. Person with finance background preferred. Computer literacy is required for candidates applying for the post.

In case of recruitment by deputation/absorption:

A) Director Level

An officer holding analogous post or an officer of the rank of DS with 5 years experience in the GP of Rs. 7600/- or an officer in the rank of US having 10 years

experience in GP 6600/- in the Govt. of India with an experience of five years in any one or more of the following areas:-

- a) Working in Economic Ministries
- b) Rural Development
- c) Women & Child Development
- d) Social Welfare

**B) Deputy Secretary Level**

An officer holding analogous post or an officer of the rank of Under Secretary with 5 years experience in the GP of Rs.6600/- in the Govt. of India belonging to the All India/Central Services with an experience of five years in any one or more of the following areas:-

- a) Working in Economic Ministries
- b) Rural Development
- c) Women & Child Development
- d) Social Welfare

Or

Scale IV or Scale V officers working in any of the Public Sector Banks/Development Banks like NABARD, SIDBI etc., with experience of Funds Management /Rural Credit /lending through SHGs/Micro Credit Programmes etc. Such deputation will normally be for two years initially and will be renewable thereafter with mutual consent for one year at a time.

Note:

(i) Period of Deputation/Contract including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/ department in Central Government / State Government shall ordinarily not exceed five years.

(ii) The maximum age limit for deputation/absorption shall be 56 years as on closing date of receipt of application prescribed.

{The crucial date for determining the age limit shall be the closing date for receipt of application from candidates in India (other than those in Andaman & Nicobar Islands and Lakshadweep)}

**3. DURATION OF APPOINTMENT:**

The appointment on deputation shall normally be for a minimum period of TWO years (Extendable further by one year at a time) or upto the date of superannuation, whichever is earlier. No application shall be entertained under any circumstances after the stipulated date. Eligible persons may submit their applications in prescribed Profoma given at Annexure-II through proper channel accompanied by the vigilance clearance and photocopies of the ACRs for the last five years duly attested by the officers not below the rank of Under Secretary to the Government of India or equivalent addressed to Joint Secretary (RMK), Ministry of Women & Child Development, Shastri Bhawan, New Delhi-1.
